"A Common Faith"

Rev. Dr. Jeff Beebe, Pastor, Trinity Palm Coast

As your pastor, I pause to reflect on our year 2023. In doing so I begin to see what changed, for the good, and the not so good of Trinity Palm Coast. And yet, we also become aware of what has not changed, yes, for the good, and the not so good. Looking back on what was the 40 Anniversary of the PCUSA we can be reminded of our denomination's not so brief, Brief Statement of Faith. In the preface, we find these agreed upon words,

In 1983 the two largest Presbyterian churches in the United States reunited. The "Plan for Reunion" called for the preparation of a brief statement of the Reformed faith for possible inclusion in The Book of Confessions. This statement is therefore not intended to stand alone, apart from the other confessions of our church. It does not pretend to be a complete list of all our beliefs, nor does it explain any of them in detail. It is designed to be confessed by the whole congregation in the setting of public worship, and it may also serve pastors and teachers as an aid to Christian instruction. It celebrates our rediscovery that for all our undoubted diversity, we are bound together by a common faith and a common task.

The faith we confess unites us with the one, universal church. The most important beliefs of Presbyterians are those we share with other Christians and especially with other evangelical Christians who look to the Protestant Reformation as a renewal of the gospel of Jesus Christ. Diversity remains. But we are thankful that in our time the many churches are learning to accept, and even to affirm, diversity without divisiveness, since the whole counsel of God is more than the wisdom of any individual or any one tradition. The Spirit of Truth gives new light to the churches when they are willing to become pupils together of the Word of God. This statement therefore intends to confess the catholic faith.

We are convinced that to the Reformed churches a distinctive vision of the catholic faith has been entrusted for the good of the whole church. Accordingly, "A Brief Statement of Faith" includes the major themes of the Reformed tradition (such as those mentioned in the Book of Order, "Form of Government," Chapter 2), without claiming them as our private possession, just as we ourselves hope to learn and to share the wisdom and insight given to traditions other than our own. And as a confession that seeks to be both catholic and Reformed, the statement (following the apostle's blessing in 2 Corinthians 13:14) is a trinitarian confession in which the grace of Jesus Christ has first place as the foundation of our knowledge of God's sovereign love and our life together in the Holy Spirit.

No confession of faith looks merely to the past; every confession seeks to cast the light of a priceless heritage on the needs of the present moment and so to shape the future. Reformed confessions, in particular, when necessary, even reform the tradition itself in the light of the Word

of God. From the first, the Reformed churches have insisted that the renewal of the church must become visible in the transformation of human lives and societies. Hence "A Brief Statement of Faith" lifts up concerns that call most urgently for the church's attention in our time. The church is not a refuge from the world; an elect people is chosen for the blessing of the nations. A sound confession, therefore, proves itself as it nurtures commitment to the church's mission, and as the confessing church itself becomes the body by which Christ continues the blessing of his earthly ministry.

(This preface does not have confessional authority but is included as an aid to interpret the "Brief Statement of Faith.")

The introductory paragraph in itself is a faith statement,

In life and in death we belong to God. Through the grace of our Lord Jesus Christ, the love of God, and the communion of the Holy Spirit, we trust in the one triune God, the Holy One of Israel, whom alone we worship and serve.

Trinity Palm Coast was just a mere 4 years of age when the Brief Statement of Faith was adopted. Trinity's worship and ministry reflects this, timely statement of belief. The Brief Statement of Faith finds itself alongside many of our creeds and confessions. Our creeds and confessions help us to not only understand what we believe to be true, but also how those truths are to be shared with others which is why,

No confession of faith looks merely to the past; every confession seeks to cast the light of a priceless heritage on the needs of the present moment and so to shape the future.

George Mehaffey (Trinity's pastor 1985-1995) was quoted using similar verbiage when he shared these now familiar words,

"Remember the past; Live in the present; And look to the future."

So yes, this Annual Report serves the purpose of looking back at the year past which helps us better understand where we are on this day, but it also provides us with an opportunity to move forward. We encourage you to read the reports of ministries herein, but with the eyes to see, and ears to hear, and the hearts and minds to understand this day where God is leading us individually and bound together as the Body of Christ. Trinity's 2023 Board of Deacons consisted of 17 deacons.

Trinity deacons made an inordinate amount of contacts to maintain our church connections. In addition, they diligently strive to maintain accurate contact information on church members. Over the course of 2023, Deacons made over 2,419 contacts with Trinity members.

Michael Peters resigned from his position as Flower Deacon in March of 2023. Flowers were then delivered by various Deacons to members who were sick when the flowers were not taken home by the person who ordered them that week.

The Deacon Assistance Fund has assisted several individuals and families this year. The Treasurer's report is submitted with this report by our treasurer, Joyce Peters.

Outgoing deacons who have finished their term at the completion of 2023 include Colleen Connors, Brenda Digby, Patty Edwards, Muriel Fallon, Sandy Glasner, Susan Kopyar.

Respectfully submitted on behalf of our committee, Marc Hitchins The Service & Outreach Committee began the 2023 year with an increase in budget to \$21,000. Most of the budget is through the <u>Family Food Program</u>. This program is in partnership with the Boys & Girls Club, the Flagler County school's weekend food backpack program, the Family Life Center and the Care Cupboard for families driving through the Food Pantry. Along with partnerships, the Family Food Program provides food assistance for our youth mission trips, youth retreats, youth after school programs and the summer vacation bible school.

The other outreach service we manage is the <u>Birthday Fund</u>. The TPC congregation participates in giving a donation on their birthday. A new Birthday card design was implemented in 2023. This has helped in receiving more contributions to this effort. The Birthday Fund helped five mission partners (Mandeville Learning Center, Old Glory Service Dogs 4 Vets, Trinity Presbyterian Church-Chinle, AZ., Family Life Center). In 2024 we are able to add Whispering Meadows back as a mission partner. We are thankful for the continued participation from TPC's congregation to the Birthday Fund.

A new program was added in 2023 to Service & Outreach. The "Hands on Mission" theme encourages the congregation to participate in meaningful missions within our church building. Mehaffey Hall has hosted several "Backpack" food stuffing activities. Food sacks are stuffed with easy meal preparation for elementary school students to address food disparity over the weekend. This "Hands on Mission" has been able to involve our congregation of all ages through a single effort.

Our informational bulletin board in the narthex keeps our congregation aware of current opportunities to volunteer as well as more information about our mission partners.

The Angel Tree program this December helped the Family Life Center children & their adult, the Special Olympics buddies, and members in our congregation. Over 30+ recipients benefited from the Angel Tree program.

The Service & Outreach committee welcomes new members to help in the mission work at Trinity Presbyterian Church. We meet on the 2nd Monday of the month at 10am. Please come and help us find ways to meet the mission need in our church, our community and elsewhere.

2023 was a year of change for the staff of Trinity Presbyterian Church. We said goodbye to our Director of Faith Formation. While we were sad to see Brooke go and all of God's love she shared with us, we were supportive of her decision to follow God's call to a new assignment working for His Kingdom. Personnel during the budgeting season decided to leave the entire salary in the 2024 budget to ensure the funds were available to hire a staff person. Discussions with the pastor and other shareholders continue to gather information in order to discern what Trinity needs and will need in the way of staff to support our future ministries.

We completed the updates on the Employee Handbook and the Session approved the document at their November meeting. We are currently working with Pastor Beebe on the pastor's job description. We will take the description to Session for approval in 2024. Next, we will update the other Personnel Policies.

Employee interviews were conducted on or around the employee's date of hire. All went well.

During the budgeting process we asked the Finance Committee and Session to consider a 3.2 % cost of living adjustment for our full-time employees since we cut their salaries and hours several years ago. The COLA was approved by both committees and was included in the 2024 budget. We changed the Music Director/Organist position back to a full-time position. We would also like to acknowledge a gift from the congregation which allowed us to give our staff and office volunteers an appreciation gift at Christmas.

We prepared the 2024 Terms of Call for Pastor Beebe in November. They were approved by the congregation in December. Moving the budgeting and approval process to the November -December timeframe facilitates payroll for 2024. The Terms of Call are reviewed, prepared, and sent to Saint Augustine Presbytery yearly.

Respectfully submitted, Steven R .Gioielli Trinity's Columbarium is in the W. K. & Dorothy S. Wilson Memorial Chapel. The Chapel, located off the narthex hallway, was dedicated and opened in 1995. It was designed and constructed by Armento, Inc. of Buffalo, N Y, under the guidance of Elder William Knox Wilson.

The Columbarium consists of 384 individual niches for the resting place of cremains. There are 11 crypts. As of the end of 2023 there are 12 available niches. Three (6) side by side and six (6) singles.

We have a proposal from Armento, Inc. for another crypt containing 32 niches. The cost is \$13,255.00 plus an estimated \$800.00+ for shipping and handling. This proposal is valid until 2/14/2024. It would be self-installed with their instructions.

The Columbarium Fund toward the purchase of the new crypt has a balance of \$9,600.00 as of 12/31/2023. About \$4,500.00 is needed to complete the purchase.

In 2023 there were 8 interments and 1 disinterment. Two niches were donated for The Rev. Dr. Jeffrey G. DeYoe and Ruth C. DeYoe.

A total of 11 niches were sold for a total of \$5,500.00. Expenses totaled \$237.50. There are two pending purchases. Niches cost \$500.00 each.

Annual Report – Finance Committee

Trinity had a good year from a financial perspective. You all continued to faithfully provide your gifts to enable Trinity to meet our mission "to be a worshiping, nurturing and serving community." Your gifts supported our annual budget, our efforts to finish paying for our Roof and Water Intrusion capital project, as well as outward facing missions of Trinity.

2023 Revenue and Expenses and 2024 Budget

Trinity Expenses and Revenue for 2023 are shown in the charts below, along with our 2024 Budget.

You may remember that the Service and Outreach Committee, Deacons, and Presbyterian Women have separate budgets from Trinity's General Operating budget. All three provide ministry to our members, our community, and other communities in need around the world in the name of Trinity Palm Coast. Please be sure to read about their work in those portions of this report. Your pledges support the approved General Operating Budget for maintenance of our buildings and grounds, utilities, personnel, worship and music, insurance, communication, stewardship campaign, office supplies, congregational life and care, and faith formation. Your gifts over and above your pledge support the ministries and work of Service and Outreach (Birthday Fund), Deacons, and Presbyterian Women.

For 2023, our approved operating budget (for revenue and expenses) was \$340,750. At the end of December, our Actual Revenues were \$330,948.16 and actual expenses were \$332,026.48. At mid-year, we had a staff vacancy, which reduced our personnel expenses for the year. At the end of the year, Session approved use of those funds for a few long-needed financial transactions, such as cleaning and sealing our tile floors. In addition, Session voted not to use Investment Returns (we had budgeted revenue of \$10,000 from investment returns for 2023) since our expenses were lower than anticipated. Through the year, our revenue consisted of

- Faithful giving of pledges by our members
- Additional gifts from friends and members,
- \$69,265 from our Heritage Fund,
- And a few smaller sources of revenue, such as Facility Usage fees

Our committee worked tirelessly to reduce expenses as much as possible. As you can see, most committees managed within their allocated budget amounts. A few committees were impacted by unanticipated expenses (such as higher than expected electrical and plumbing repair costs) or inflation (such as insurance). Trinity contributions to the Presbytery of St. Augustine included per capita of \$3,403.42 and a gift of \$3,500 for Unified Giving. In total, our expenses were \$1,078.32 more than our revenues for 2023.

In December 2023, Session approved a balanced budget of \$352,100 for 2024. This represents an increase of about 3.3% in our annual budget. The 2024 budget includes

- funds to fill our staff vacancy (Session will decide, but funds are in the budget)
- cost of living or hour increases for some of our staff
- a substantial increase in insurance costs
- movement of some large possible expenses out of our annual budget (to be funded from restricted funds if needed), and
- other increases determined by our committees

Stewardship and Giving

Trinity had a very good Stewardship campaign for 2024. As of January 4, 2024, we received pledges for a total of \$204,678, which represents an increase of more than 4.6% over pledges at this same time last year. That amount was pledged by 98 "pledging units" (households or families who submit pledges). Last year we received 104 pledges. So, the number of pledges we received decreased, but the amount pledged still increased substantially. Our sincere thanks to everyone for giving as you are able. We still have 18 giving units who pledged for 2023 but have not yet pledged for 2024. If you are in this group, it is not too late. Simply fill out your pledge card (extras are available in the office) and mail it, put it in the offering plate, or put it in Judy Grady's mailbox.

Your pledges were used to develop the 2024 budget for Revenue shown in the charts above. We are very grateful to those who return pledge cards, providing their financial commitment which we can use to estimate revenue for our budget.

You can give to Trinity in a variety of ways. Online giving is available through our financial management system (on Trinity's website <u>www.trinitypalmcoast.org</u>), including use of a QR code which is in the bulletin every week. Our offering is collected during Worship each week. Contributions may also be mailed to the church or dropped by the office during the week. We have a brokerage account and can receive your gifts of stock or annual distributions this way as well. Call the church office for information needed to transfer funds or assets.

As you see in our Revenue budget, we balance our budget using money from our Heritage Fund. For 2024 we will use \$72,839 from Heritage Fund in our annual budget. The Heritage Fund was established in 2021 to support, maintain and strengthen ministries of Trinity Presbyterian Church of Palm Coast, today and in the future, by strengthening the vitality and financial soundness of the church. The fund was initially seeded by a substantial estate gift. Since that time, we have received several additional gifts, including another substantial estate gift in 2023. As of the end of 2023, we have approximately \$341,650 in our Heritage Fund. Our hope is that members will make an "above and beyond" gift to this fund to advance Trinity's ability to serve our congregation, community, and the world for generations to come. All members can contribute to the Heritage Fund through estate bequests, stock or bond gifts, gifts from retirement assets (such as 401K Required Minimum Distribution) or annuities, IRA, 401K or insurance beneficiary designations, bonus earnings, or any other source available to members. There is no minimum amount for contributions to this fund.

Annual tax statements were mailed to donors early in 2023 for tax year 2022, and donor statements were sent multiple times during the year.

Roof and Water Intrusion Financial Update

While our project to repair/replace our roof and repair damage from water intrusion is complete, we have not yet fully paid for this capital project. Total costs for the project came to \$337,241, including estimated interest for repaying our PCUSA loan at the end of 3 years. We used \$120,000 from our capital repair restricted fund to help pay for the project. To date, we have received \$145,453 in capital campaign contributions and we have an additional \$28,092 that members pledged to pay over the 3-year campaign. That leaves a need for \$43,696 in additional money to pay off our loan for this project. Our PCUSA loan has fixed interest for 5 years, and is then subject to a change in interest rate. Our goal is to pay off the loan before that 5-year time period is up (by July 2028). If you are able to help, contributions can be designated for "Capital Campaign" or you can contact Judy Grady to make a pledge.

Investments Update

The Finance Committee has prayerfully managed Trinity's large gifts and investments this year. We decided to use a variety of ways to invest church funds. We continue with our investments in New Covenant Funds, both Income and Growth Funds. This year we felt more secure investing in a T-Bill and CDs since markets were volatile and interest rates were higher. We are earning about 5% on the T-Bill and CD investments. When we rolled over the CDs in November, we rolled over the interest and added \$30,000 of Roof project funds and \$30,000 from the final distribution of the Keyes estate to the Heritage Fund. *These totals are displayed in the chart below.

The New Covenant Account 1 is an estate bequest restricted to specific mission purposes. Earnings from this account were used for those purposes by Service and Outreach. New Covenant Account 2 is the account from which we withdrew \$120,000 to assist with the Roof/Water Intrusion Project. Dividends from the Presbyterian Foundation endowment and earnings from the New Covenant account are sent to the church and held until needed in a restricted account. We did not use the earning from our investments in the 2023 budget. ** The Truist account received a stock donation for a Roof Project pledge.
